Based on Article 19 of the Law on Non-governmental Organizations ("Official Gazette of Montenegro", number 39/11), in the process of registration of a new fact in the Registry of Non-governmental Organizations, and acting upon the application of the Association named "Association of Youth with Disabilities of Montenegro" from July 16, 2012 and update of this application from July 31, 2012, the Ministry of Interior adopts a

DECISION

In the Registry of Associations under the ordinal number 1322, section 4, a change shall be made and the fact about the new Statute of "Association of Youth with Disabilities of Montenegro", with headquarters in Podgorica shall be entered.

By entering the changes of fact from the item 1 of the enacting terms of this Decision in the Registry of Associations, the non-governmental organization named "Association of Youth with Disabilities of Montenegro" has harmonized its Statute with the current Law on Non-governmental Organizations ("Official Gazette of Montenegro", number 39/11).

EXPLANATION

The Association named "Association of Students with Disabilities of Montenegro" with headquarters in Podgorica was registered in the Registry of Associations under the ordinal number 1322 based on the Decision of the Ministry of Justice number 02-5048/01 from October 22, 2001, the same Association having changed its name into "Association of Youth with Disabilities of Montenegro" based on the Decision from June 9, 2003.

In a memo from July 16, 2012, signed by Marina Vujačić, as a person authorized to represent the Association, the said Non-governmental Association notified the Ministry of Interior that the Decision on harmonization of the Statute of this organization with the current Law on Non-governmental Organizations had been made at the meeting of the Board of Directors of the Association held on June 26, 2012. Along with the memo, an excerpt of the minutes from the meeting has been delivered, as well as the new Statute of Association adopted at the meeting of the Board of Directors of the Association held on June 26, 2012, so it has been decided as in the enacting terms of the Decision pursuant to Articles 19 and 49 of the Law on Non-governmental Organizations.

The Decision has been adopted, its form and integral parts being pursuant to provisions of Article 201, paragraph 1, Article 202, paragraph 1 and Article 203, paragraph 1 of the Law on General Administrative Procedure ("Official Gazette of Montenegro", number 60/03 and "Official Gazette of Montenegro", number 31/11).

Legal remedy: This Decision is final and the appeal against it can be filed to the Administrative Court of Montenegro within 30 days since its delivery.
