Pursuant to Articles 14 and 19 of the Law on Non-Governmental Organisations ("Official Gazette of Montenegro", no. 39/11 and 37/17) and Article 46 of the Law on Administrative Procedure ("Official Gazette of Montenegro", no. 56/14, 20/15, 40/16 and 37/17), the Ministry of Public Administration in the process of entering a new fact into the Register of NGOs, acting upon request filed by the NGO "Association of Youth with Disabilities of Montenegro", dated 15 May 2019, hereby issues the following

DECISION

The following changes shall be made in the Register of Non-Governmental Organisations, under the ordinal number 1322, items 4 and 7: the adoption of the new Articles of Association and the election of a new person authorised to represent the non-governmental organisation "Association of Youth with Disabilities of Montenegro", adopted at the meeting of the Assembly on 17 April 2019.

The new authorised person is Marina Vujačić.

Reasoning

According to a Decision issued by the Ministry of Justice, No. 02-5048/01 dated 22 October 2001, "Association of Students with Disabilities of Montenegro" was entered into the Register of Non-Governmental Organisations under the ordinal number 1322, and according to the Decision no. 02-5048 of the Ministry of Justice, dated 9 June 2003, it changed its name to "Association of Youth with Disabilities of Montenegro".

Non-governmental organisation "Association of Youth with Disabilities of Montenegro" submitted to the Ministry of Public Administration on 15 May 2019 a request to enter information on the adoption of the new Articles of Association and the election of a new person authorised to represent the Association.

Decisions of the Assembly meeting held on 17 April 2019, in which the new Articles of Association were adopted and a new authorised person was elected, were attached to the request submitted on 15 May 2019, therefore by applying Article 19 of the Law on Non-Governmental Organisations, it has been decided as written in the enacting terms of the Decision.

<u>Legal Remedy:</u> This Decision may be appealed to the Administrative Court of Montenegro, within 20 days of receipt of the Decision.
